Conditions of Play

1. **Laws & Regulations:** Played under the Laws of the Sport of Bowls and Bowls New Zealand Domestic Regulations as applicable.
2. **Controlling Body:** The controlling Body for this event is the Bowls North Harbour Match Committee.
3. **Trial Ends:** One trial end played in each direction, will commence 15 minutes before the start of play.
4. **Start Time:** Play will commence as soon as all players are available on each playing day at each venue but no later than 5:45PM.
5. **Clothing:** Players in a side will be in mufti, club shirts or their club uniforms, or whites/creams for the qualifying rounds. Club uniforms or whites/creams to be worn on finals day.
6. **Clubs** – Once you have represented one club in any one round, a player is ineligible to represent a different club in this same competition.
7. **Teams:** Teams to consist of one singles player, 1 pairs team, and 1 triples team.
 - a) Teams may be re-selected after each round of the competition
 - b) Players may play in any position within the team in the different rounds of the competition.
 - c) If more than one team is entered from one club, players cannot change between the teams unless approval is obtained from the Bowls North Harbour Match Committee.
8. **Match Conditions** – A match will consist of three games between two clubs.
 - a) One game of singles (4 bowls each) – First to 21 shots or 1hr 45min time limit
 - b) One game of pairs (3 bowls each) – 15 ends or 1hr 45min time limit
 - c) One game of triples (2 bowls each) - 15 ends or 1hr 45min time limit
9. **Killed End:** The jack is to be spotted on the 2 metre mark
10. **Tie in qualifying play:** In the event of a Tie in qualifying play, NO extra end(s) will be played
11. **Incorrect Jack Delivery:** An incorrectly delivered jack will not be returned but will be placed by the opposing skip, or in singles placed at the discretion of the opposing player.
12. **Defaults:** If a team defaults, their score will be recorded as a loss. The non-offending team will be awarded a win and the average net total of shots scored by the winning teams in the same round of the same section.
13. **Late Appearances:** When any team has failed to be in position to commence play **15 minutes** after the scheduled starting time, the game will be awarded to the opponent.

14. Determining a Winner:

- a) In all games three points will be awarded for each game won, and one point will be awarded for each game drawn.
- b) Where game points are equal the winner of each section will be the team with the highest net total of shots (differential).
- c) If the game points and the net total of shots (differential) are equal, the team with the lowest total shots against will be the winner
- d) If these are also equal, the team that that won the match when the two teams met will be the section winners

15. Finalists:

- The top 2 teams in each section will qualify for the quarter-finals
- Quarter finals will be seeded as follows:
 - QF 1 – Winner Section 1 vs Runner up Section 4
 - QF 2 – Winner Section 4 vs Runner Section 1
 - QF 3 – Winner Section 2 vs Runner up Section 3
 - QF 4 – Winner Section 3 vs Runner up Section 2
- The winner of each Section will get home ground advantage for the quarter-final – i.e. the winners of each section will host their quarter final on Monday 18th February
- Semi-final and Final venues will be appointed once the teams who have reached this stage have been found.

16. Inclement Weather:

Should inclement weather or any other circumstance prevent a round being completed fully then:

- a) Monday 11th March is set down as a reserve day and can be used in case of an evening being washed out.
- b) If inclement weather is an issue, a decision will be made by 3pm each Monday whether play will go ahead – this will apply to all venues.
- c) If an evening is washed out, the entire schedule will be moved back a week to accommodate this.
- d) In the event of more than one week being washed out the Bowls North Harbour Match Committee will make a decision on how to best progress the competition to a conclusion.

17. Team Manager: Each team is to have a manager who must NOT be a player in the side. (This person can be the designated marker for the side). The manager must list the names of players on team sheets before play commences, complete the results section of their team sheet and sign both their own and their opponents team sheet. Managers toss at the beginning of the round (one toss for all 3 games in the round) and the winning club shall decide whether the team will take or give the mat away. Each manager must sign off the results chart at the end of play.

18. Host Club: Results - The host club is responsible for the issue and collection of cards for each round of the competition

19. Umpires: As umpires are not appointed for this competition, Team Managers and/or host club organisers are required to adjudicate to resolve disputes, and to undertake measuring when required

20. Smoking Policy – There shall be no smoking on the greens or immediate surrounds. Smoking areas will be designated at each venue as advised by the host club duty officer. Please be advised that some clubs in North Harbour are completely smoke-free clubs

21. Alcohol Policy – Alcohol shall only be consumed in areas defined by the host club liquor licence and in no event be allowed on the green or surrounds during play.
