Sponsorship/Grants

We will be able to apply for more grants in February, as we have been restricted by the number of applications we can make in any given period.

Coaching

We now have an accurate up to date list of all our active coaches in North Harbour. We will be making contact with them in February.

We are working with Ryman Healthcare, who are sponsoring the build of a covered-in trailer (mobile coaching resource). This is exciting and our plan is to have Ryman's advertising on this. The trailer will hold 20 sets of bowls, and other resources (screen, video, etc). It is a joint venture with Ryman and Bowls North Harbour and will be used for flying squad coaching at clubs and at retirement villages...all very exciting.

Other

Gary S, John M and I met with the Council in December. Discussions centred on whether the Council could issue a 10x10x10 lease to a club (Council lease), if the long term proposal could be to build a covered stadium.

(essentially, if there is a financial commitment of \$4m sourced from outside the Council, the first stage must be a long term lease)

The Council have advised there may be an opportunity to advocate to the Council board for a 10x10x10 lease based on evidence of investment levels going into the project, alignment with the regional plan and potential merging of clubs.

Nationals

3 clubs in North Harbour were utilised by Auckland Bowls for the hosting of the Nationals in early January. Unfortunately, our three clubs were not notified until a few weeks prior to their hosting of the event. We advised Bowls NZ of our concerns and have received a prompt reply where they have assured us that their processes and disciplines will be better in future in terms of communication.

Our 3 clubs (Birkenhead, Takapuna, Milford) received compliments from both players and organisers for their contribution to a successful Nationals.

Absolutely amazing performances and results from a large cross section of North Harbour bowlers who played in the Nationals. Without question, this has been the best result in terms of going deep into a tournament...well done!

Pennants

Following a survey sent to players, the Centre convened a meeting with clubs on Tuesday 29th January to discuss the 2019/20 pennants competition. The comments from clubs generally mirrored the survey results from players. It is proposed that the match committee, together with 4 nominated club representatives, sign off on the pennants programme.

From Match Committee,

Pennants – The competition had two wet days towards the end of the ten week's play but the finals were played in very good weather at Browns Bay. This was a very good day for bowls. A review of the competition format is now being undertaken to consider the future.

Men & Women Centre Fours – Competition was completed as scheduled. There were some questions over the format with a draw not being recognised in round robin play and it was felt this was a disadvantage to some teams. It was acknowledged the conditions of play needed to be changed to reflect a draw for future centre events.

Men & Women Centre Pairs – Competition completed in January.

Master's Fours – The lack of entries resulted in this event being postponed. The Masters events will now be held on Mondays in February and March starting with the pairs on 25 February. This will be followed by the triples on 18 March and fours on 25 March. They will also be held as "any combination" events this year. Format for these events have been modelled on the proposals being considered for the NZ Masters in February 2020.

Junior Interclub - Fourteen teams were entered for this event and various options were considered in regards to the draw. Whilst it was not perfect the four section draw was considered the best option to sort out teams, venues and qualifiers. Unfortunately the first nights play was abandoned but this should not affect the competition as there were reserve days in the programme.

Shots v. Differential in section play – On request this was considered and agreed that differential should be the preferred option in section play for events.

Bowls3five – This competition is scheduled for February/March. The COP have been finalised and draw made with three sections of four teams in each.
