**Conditions of Entry:**

1. Each club may enter a maximum of two sides
2. The number of players in each club side will be 9 players and must be mixed with a minimum of 3 females and 3 males in each side playing a minimum of 1 of each gender in each triples team.
3. Play will be in a team of one triples team, playing 2 bowls each player in two sets of 5 ends for each game played.
4. All players in each club side must be members of the same club
5. No sponsored side names will be accepted if found to be in conflict with any of the of the Bowls North Harbour sponsors
6. Qualifying games will be played in the evenings with up to two games played on an evening in each week. Which evening of the week can be decided by the teams in that zone but all teams in that zone must play on the same evening
7. For ease of access and travelling clubs will be allocated to zones, subject to entries received, and could be based on something similar to the PPL competition held earlier in the season. This allocation was --
  - Zone 1 – Warkworth, Mahurangi East, Omaha Beach, Manly, Orewa
  - Zone 2 – Helensville, Waimauku, Riverhead, Hobsonville
  - Zone 3 – Belmont Park, Takapuna, Milford, Mairangi Bay, Browns Bay
  - Zone 4 – Beach Haven, Birkenhead, Northcote, Sunnybrae
8. The Match Committee reserves the right to move clubs between zones when entries are uneven in any particular zone/s or make any other decision to facilitate the competition
9. The winner of this competition will represent Bowls North Harbour in the Regional and National finals which will follow on from this competition.
10. Entry fees will be \$60 per side to accompany entries.
