## 3. BOARD REPORT

TP highlighted a few points from the report

- 1. Membership numbers now 1,436, on a downward spiral
- 2. Some events were missed due to Covid-19. The Champ of Champ events to be run in July, but the Champ of Champs at a National level has been cancelled for the 2019-20 season
- 3. The first edition of the New Zealand Master bowls was successfully run in February and will be repeated this next season
- 4. The Representative teams had some successful tournaments against neighbouring centres but the National Intercentre competition in Wellington was unfortunately cancelled
- 5. BNH took delivery of the Ryman Coaching trailer complete with 20 sets of bowls and is now available for the clubs to use

## 5. CONSIDERATION OF BUDGET FOR YEAR TO 30TH APRIL 2021

The board had considered the budget for 2020/21.

All income is expected to be lower due to Covid-19 impacting on the opportunity to get grants, but a watchful eye will be kept on all opportunities to increase income

Expenditure is expected to be in line with the previous year

Included in the budget is an amount to cover the replacement of the Representative uniforms and there is unused expenditure for the Inter-centre tournament which can be utilised in the next season A net deficit is expected but the centre has good reserves in the Balance sheet

## 7. ELECTION OF THE MEMBERS OF THE CENTRE BOARD

Neil Connell, Michael Beretta, Murray West, Gail Dick and Norma Klaassen are all continuing into their 2<sup>nd</sup> year of a 2-year term.

The Board has received one nomination for the one vacancy from Tony Popplewell (Mairangi Bay)

The constitution allows for the President, Vice-President plus up to 6 board members.

Maureen Taylor declared Tony Popplewell elected to the Board for a 2 year term

Lesley Langer will continue as Centre Secretary/Events Manager Raewyn Thomas will continue as Treasurer Lindsay Knight will continue as publicity officer Jean Ashby as our Laws Officer and Kevin Holland has agreed to remain Patron of the Centre

#### 11. NOTICES OF MOTION

The Board has received 2 notices of motion that comply with Clause 23.4 of the Constitution. The notices of motion have been circulated to all club boards. The attending delegates have a voting pack and are entitled to a number of votes depending on the size of the club. The total votes available to the clubs attending are 33 votes

- 1. Proposal for Honorary Life Membership for Jean Ashby
- 2. Proposal from Browns Bay Bowling Club to amend the conditions of play for plural membership to read —

Dual membership – A full playing member, who is a member of more than one Bowls North Harbour Club, shall not play the same Club Championship in more than one club. For clarification this means the player may elect to play one discipline (e.g. the singles) at Club A and another discipline (e.g. the pairs) at Club B but cannot play the same discipline (e.g. singles, pairs, triples or fours) at both Clubs A & B whether they have been successful in winning the Championship or not.

## 12. GENERAL BUSINESS:

1. Tony talked to the paper on BNH membership fees. He said clubs currently pay an affiliation fee to Bowls NZ and a membership fee to Bowls North Harbour. The concern BNH has is as the membership numbers decline the revenue BNH receives from the clubs is also declining. BNH is not promoting any change at this stage. The white paper outlined a few options that may be considered in the future. The centre would like the delegates to take the discussion back to the clubs and get some feedback on their thoughts

Chub Roberts (Hobsonville) said even though they have two greens they are a small club and would not like to see any fees based on the number of greens

2. Online entry of Centre events is being developed for the BNH website. Individual events will be entered online by the player/s and paid online by the player/s. Events entered by the club like Winter cup, Pennants etc will be entered by the nominated person at the club. An invoice will be generated at the end of that entry which will need to be given to the club Treasurer for payment. One invoice per entry

The centre are hoping to have it ready for the start of the season, ie for the Executive Fours

- 3. Bowls3Five next season has changed, only have 3 players per team instead of the 9 players in a team currently. The event will be run on a section play and post section basis towards the end of Nov and clubs can enter multiple teams as they want. There will no longer be a junior Bowls3Five event
- 4. The awards function is re-scheduled for 16<sup>th</sup> August after the Champ of Champ events are completed
- 5. Summerset National Singles and Pairs in January will be hosted in the Auckland district.
- 6. Garry Moverley (Birkenhead) asked what format the Pennants is to be played this coming season. The Premier divisions are only allowed 1 team per club but the other divisions can have multiple entries from a club, that is Division1, Mixed Division A and B.

Martin McKenzie was invited to address the meeting. He brought all up to date with what is happening at Bowls New Zealand

Graham from Manly asked Martin about casual bowlers that play for an extended period of time prior to joining a club as a junior, which is not fair on the genuine new bowlers. Martin said that Bowls NZ does not have any ruling on this.
