FOOD:

Each Centre to be responsible for organising lunches for their players

COMPOSITION OF SIDES:

PREMIER 1 MEN & WOMEN – Teams of seven consisting of 1 singles/1 pairs/1 fours – individual Centre's to decide on whether they will use substitutes between rounds. Centre's can interchange players between disciplines across each of the three rounds. Players can be interchanged between Premier 1 and Premier 2 squads across each of the three rounds.

PREMIER 2 MEN & WOMEN – Teams of seven consisting of 1 singles/1 pairs/1 fours – individual Centre's to decide on whether they will use substitutes between rounds. Centre's can interchange players between disciplines across each of the three rounds. Players can be interchanged between Premier 1 and Premier 2 squads across each of the three rounds.

A list of names of all players shall be provided by each Centre to the Controlling Body on the day, this to include individually identified Manager and Coach.

THE DRAW: shall be completed by the Host Centre

CONDITIONS OF PLAY:

1. **Laws and Regulations:** Played under the Laws of the Sport of Bowls and Bowls New Zealand Associated Regulations as applicable.
2. **Controlling body:** The controlling body for this tournament is the Managers from each of the four competing sides. The controlling body will have the right to alter, add to or delete any conditions of play and/or special conditions to enable the completion of the tournament.
3. **Trial ends:** Prior to the start of play for the day, each player will be allowed two trial ends.
4. **Bowls:** Singles – Four (4) bowls; Pairs – three (3) bowls each; Triples – two (2) bowls each; Fours – two (2) bowls each.
5. **Games:** Singles 21 shots; Pairs and triples 18 ends; Fours 15 ends or 2 (two) hours per game time limit.
6. **Advice by Coach:** The Coach or their appointed substitute can give advice to a player (s) in their side during the course of the competition in accordance with Laws of the Sport of Bowls (Crystal Mark Edition). The names of the team Manager and team Coach must be handed to the convener before the commencement of play.
7. **Clothing:** Players footwear and clothing must comply with the provisions of Laws of the game.
8. **The jury of appeal:** will consist of one representative from Auckland, North Harbour, Northland, and Bay of Plenty Centre's.
9. **Restricting movement of players:** In all games players will only be allowed to walk up to the head under the following circumstances:-
 - Singles: After delivery of their third and fourth bowls.
 - Pairs: Leads: After delivery of their third bowl.
Skips: After delivery of their second bowl.
 - Fours: Leads: After the delivery of their second bowl.
Twos: After the delivery of their second bowl.
Thirds: After the delivery of their second bowl
Skips: After the delivery of their first bowl.
10. **Time limit:** In all games there will be a time limit of Two hours.
11. **Variations to conditions of play:** In the event of inclement weather or other extraordinary circumstances the Controlling body may vary the conditions of play by reducing the number of ends and/or time limit of any game, or reducing the number of games but any decision must be made before the commencement of a game.

12. **Determining a winner:** In all games three points will be awarded for each game won and one point for each drawn. Where game points are equal, the winner will be the team with the highest differential. If the game points and the total of net shots are equal, the team with the lowest “total shots against” will be the winner. If the game points, net total shots scored and net total shots against are equal the winner will be decided on the result of the games played when the two sides met.

13. **Results will be awarded as follows:**

Premier 1 Men	Premier 2 Men
Premier 1 Women	Premier 2 Women

14. **Inclement weather:** If play is stopped due to weather conditions,

Singles 15 shots,

Pairs 9 ends,

Fours 7 ends,

shall constitute a game.

An end still in progress when the bell rings shall be cleared.
