## **CONDITIONS OF PLAY**

- 1. **General Conditions:** The "General Conditions of Play" as they are applicable on the Bowls North Harbour website will apply to this event to the extent they are applicable.
- 2. Play will commence by: 9.00am on Saturday 10 February and 9.00am on Sunday 11 February.
- 3. Bowls: Each player will play 2 bowls in each end.
- 4. Dead Ends: If an end becomes dead it must be replayed
- 5. **Restricting the Movement of Players During Play:** In all games, players will only be allowed to walk up to the head under the following circumstances:

Leads: after delivery of their second bowl.

Twos: after delivery of their second bowl. Threes: after delivery of their second bowl.

Skips: after delivery of their first bowl.

- 6. **Time limit:** A time limit of 2½ hours will be applied in qualifying play and all post section games apart from the final. The final will have no time limit. If the jack has been delivered before the end of the signalled time, the end will continue and if it subsequently becomes dead it will be replayed.
- 7. **Qualifying:** Entries will be drawn into sections with a round robin of 3 games of 15 ends or 2 ¼ hours. All games in qualifying must be completed in full if the result has any bearing on the potential qualification of any team within the section.
- 8. **Ties in qualifying play:** If a game is tied at the completion of 15 ends, or after the end is completed when the time limit is signalled, or at the completion of the minimum of number ends as stated in Condition of Play "Inclement Weather" below, then both teams will be awarded 1 point.
- 9. **Byes in Qualifying Play:** Should there not be an even number of teams then a section(s) may contain a bye. The bye will be treated as a win and no shot differential applied.
- 10. Defaults: If a team defaults their score will be recorded as a loss. If all rounds of section play are completed, the winner of the section will be determined from the result of all games played in that section between the remaining teams. If due to weather or other circumstances all rounds of section play are not able to be completed, then the non-defaulting team in each round will be awarded a win and the average net total of shots scored by the winning teams in that same round played in the same section.
- 11. **Determining a Section Winner:** Three points will be awarded for each game won. 1 point will be awarded to each team if a game is tied. Where game points are equal the winner of each section will be the team with the highest net total of shots. If the game points and the net total of shots are equal the team with the highest total of shots scored will be the winner. If these are equal, the team that won the game when the two teams met will be the section winner. If still equal an extra end must be played between the two teams.
- 12. **Post Section:** The winner from each section, plus the next best team over all sections, will qualify to Post Section play. The next best team will be determined by the same process as in "Determining a Section Winner". A blind draw will be done to determine the order of play. Post Section play will be to find a winner of each game played. If the scores are tied at the completion of 15 ends, or at the completion when the time limit is signalled, then one further end will be played to determine a winner.
- 13. Inclement Weather: During qualifying play, if weather conditions affect play a minimum of eight [8] ends will constitute a game. If weather forces abandonment of play, two completed games will constitute completion of section play, and a result found from the two completed games. Each venue will be considered a separate competition when applying this condition. If weather forces abandonment at any one venue before the completion of at least two games of qualifying, the balance of events will be transferred to Day Two. If Day Two play is affected by weather conditions, the balance of games will be transferred to the next available reserve day.
- 14. Trophy and Prize Money: The presentation of the trophy and prize money will be made immediately following the conclusion of the final.
