- Demonstration of successfully implementing new initiatives and procedures to green management aligned with objectives around cost saving, and OSH and HASNO regulations.
- Demonstration of dedication and a planned, sustained approach to their growth and success as a green keeper, including awards and qualifications gained.
- Demonstration of them sharing knowledge and contributing to the growth and expertise of the greenkeeping fraternity.
- Good rapport with appointed NZ Sports Turf Agronomist and respected by all for their contribution to the sport.
- Green ratings will be taken into consideration.
