BOWLS NORTH HARBOUR MATCH COMMITTEE (MC) REPORT TO THE BOARD 15 March 2024

INTERCLUB 7'S: This competition was concluded on 10th March which was the official reserve day allocated to complete the event. The event had a number of challenges but overall, the two club winners were found, who are able to progress on to the national finals. As there was the request for more teams to be entered in the competition, the MC had opened a second division for play between clubs. Unfortunately, with only two entries eventuating for the women's second division this competition was not proceeded with. The men's second division competition drew a respectable 12 teams.

Unfortunately, heavy rain closed the greens at Browns Bay on the second day which came in the middle of the second game. This caused the event to be postponed for the rest of that day and those games were concluded on the re-commencement of the competition the following weekend. This resulted in a number of team changes for a variety of reasons which were all approved by the MC.

A number of other deficiencies emanated from the event - through minimal support at hosting clubs, lack of markers supplied by the teams and shortage of umpires at the venues, although a number of the umpires were actually playing in the event.

The results were -

Women – Mairangi Bay, with Takapuna the runners-up;

Men Division 1 – Takapuna, with Birkenhead the runners-up;

Men Division 2 – Manly, with Mairangi Bay the runners-up.

CADNESS CUP: This event is progressing with two days completed of qualifying for both the men and the women. Both are scheduled for completion on Friday 22 March with the men at Milford and women at Manly.

GENERAL: We now move into the end of season events with 1-5 year events and Champ of Champ events to be held through April and May.

The MC will be meeting shortly to formulate plans for next season events as we conclude these events for this season.
