## SPECIAL CONDITIONS OF PLAY for the BNH Mixed 2-4-2 Pairs

- 1. **General Conditions:** The "General Conditions of Play" as they are available on the Bowls North Harbour website will apply to this event to the extent they are applicable.
- 2. **Greens:** This event will be played on artificial surface greens.
- 3. Dress Code: Mufti, team colours or club colours may be worn for this competition
- 4. **Jack Delivery:** An incorrectly delivered jack will be placed by the opposing team. If the jack has been delivered before the end of the signalled time, the end will continue and if the end subsequently becomes dead it will be replayed.
- 5. **Dead Ends**: If an end becomes dead it must be replayed in the same player sequence as that end which was being played.
- 6. **Restricting the Movement of Players During Play**: In all games, players will only be allowed to walk up to the head under the following circumstances:

  The player from each team who is playing the final two bowls of the end is allowed to visit the head before

delivering their final bowl.

- 7. **Qualifying**: Entries will be drawn into sixteen sections of four teams playing a round robin of three games. All games in qualifying must be completed in full if the result has any bearing on the potential qualification of any team within the section.
- 8. **Ties in Qualifying Play:** If a game is a tied at the completion of 12 ends, or after the end is completed when the time limit is signalled, or at the completion of the minimum number of ends as stated in the conditions of play "Inclement weather" below, then both teams will be awarded one point.
- 9. **Byes in Qualifying Play**: Should there not be an even number of teams, then a section(s) may contain a bye. The bye will be treated as a win and no shot differential applied.
- 10. **Defaults:** If a team defaults their score will be recorded as a loss. If all rounds of section play are completed the winner of the section will be determined from the result of the games played between all teams remaining in the section. If due to weather or other circumstances all rounds of section play are not able to be completed, then the non-defaulting team/s will be awarded a win and the average net total of shots scored by the winning team or teams in the same round in the same section.
- 11. **Determining a Section Winner:** Three points will be awarded for each game won. One point will be awarded to each team if a game is tied. Where game points are equal the winner of each section will be the team with the highest net total of shots. If the game points and the net total of shots are equal the team with the highest total of shots for will be the winner. If these are equal, then the team with the lowest total shots against will be the winner. If all these are equal, the team that won the game when the two teams met will be the section winner. If still equal an extra end must be played between the two teams.
- 12. **Post Section:** The winner from each section will qualify to Post Section on Sunday 14<sup>th</sup> September. Post Section play will be to find a winner of each game played. If the scores are tied at the end of 12 ends, or after the end is completed when the time limit is signalled, then one further tie-break end will be played to determine a winner.
- 13. Inclement Weather: During qualifying play, if weather conditions affect play a minimum of eight [8] ends will constitute a game. If weather conditions forces abandonment of play, two completed games will constitute completion of section play, and a result found from the two completed games. Each venue will be considered a separate competition when applying this condition. If weather forces abandonment at any one venue before the completion of at least two games of qualifying, the balance of events will be transferred to Day Two. If Day Two play is affected by weather conditions, the balance of the games will be transferred to the next available reserve day.
- 14. **Trophy and Prize Money:** The presentation of trophy and prize money will be made immediately following the conclusion of the final.
