Centre Manager Report:

1. General Operations

- Continued day-to-day operations including responding to club enquiries, updating competition results, and maintaining communication channels.
- Supported the preparations and successful delivery of the 2025 AGM and Awards
 Presentation held on 22 June at Takapuna Bowling Club. Special thanks to Robyne Walker
 and the volunteers for their coordination and flexibility, particularly around catering
 logistics. A great effort by the board to ensure the AGM and the Awards function ran
 smoothly.

2. Competitions and Events

- Collated entries for the upcoming Winter Coaching Series being held on Saturday mornings in July
- Work has begun on liaising with clubs regarding availability and event hosting for the 2025–2026 Centre Programme.
- Winter coaching registered players 5th & 12th July
- Sold 7 of the 8 sets of Henselite Bowls. 1 set size 4 available at \$400
- Observed 1-8 Year Lattimer Cup at Browns Bay 15 July 2025 and made announcement regarding applications for rep teams – close date 22 July 2025. Lattimer won by Harris / McQuoid team from Bowls Orewa.
- Collated registrations for the Foundation Coach courses on 15, 22 & 29 July 2025 at Bowls Orewa – 16 participants.

3. Representative Programme

 Issued the Expression of Interest (EOI) for Coach/Selector roles for the 2025–2026 representative season. Applications are being received and collated for review by the Representative Team Director.

4. Communication & Systems

- Coordinated ongoing updates through the BowlsHub platform and maintained Centre website and Facebook content.
- Supported club users with troubleshooting and entry guidance for BowlsHub event registration.
- Began testing and early familiarisation with Bowls+, the new BNZ communications platform, including integration planning with Centre messaging.

Summary:

The past four weeks have been a period of consolidation, event wrap-up, and forward planning. The Centre is well-positioned for the transition into the 2025–2026 season, with key personnel processes underway and communications systems being enhanced. Continued engagement with clubs and volunteers remains a priority as we build towards the season launch.

The Centre Manager's report was taken as read with no questions arising from it.

Representative Report:

John Walker Representative Team Director

The past month has been spent communicating with both Players and Possible Representative Selectors plus attending the first coaching session held a Orewa

The response to our expression of interest applications for the Selectors role has been disappointing hence a lot of my time has been spent talking to persons who I feel could add value to the Selection team and sharing with them my vision for the coming season.

One of my main concerns is what appears to be a lack of a Budget for Representative teams. It is most important that a Budget is available for the team selectors. They need to know budgeted expenditure to ensure no expenditure is incurred that has not been included in the annual budget. We do not envisage large amounts being spent but would appreciate guidelines being provided for us to work within. Expenditure outside of this budget would quite clearly be presented to the Board for their approval.

Coaching. The clinic at Orewa was a pleasant surprise and well done to those responsible. Whilst my main concern at this time is to get the Selectors and their teams appointed the Coaching provides an important pathway for those that may aspire to represent BNH.

The Representative Team Directors (RTD) report was taken as read.

It was suggested that the representative team coaches should be registered coaches, and they should gain certification.

The RTD proposes to hold a representative launch event with a guest speaker, prior to the start of the representative fixture. The format and a draft budget are to be prepared and submitted.

Match Committee Report:

COMPOSITION OF COMMITTEE: The MC has over recent months worked with a minimal number on the committee and as we were following the previous season events which were heavily scrutinised by the then MC, there was minimal involvement required. As we now commence a new season and with a new board member in Mark Batley on board with some previous club experience, we have invited him onto the MC. The MC will now consist of Tony Popplewell (Convenor), Mark Batley, Hanaan Shahwan, Neil Connell and Garth Partridge. A further member may be invited during the next season to continue the progress of transition.

RECENT EVENTS: The Winter Cup has completed the first day play and moves to the second and final days on the next Fridays.

FUTURE EVENTS: The MC has met and considered the allocation of greens for the events up till December. This has been based on similar size entries that we had last season. The CM is now progressing this with clubs to seek confirmed venues.

We have also made temporary allocation of Event Directors to the events and again this will firm up after entries have closed and we know the greens being used.

Mark Batley has also expressed interest in this side of the events and will be introduced to it over the coming events.

With uncertainty of entries for the pennants series we have not tried to source venues at this stage. As it is being run on Fridays, and clubs entering are asked to make their greens available, we do not see a problem here. There are some positive vibes with the suggested format so will be interesting when the entries are called.

DUAL MEMBERSHIP: This subject has raised its head during the recent Champ of Champ events. A previous MC had established a policy at variance with the BNZ conditions of play for CoC events and this was included as Regulation 6 in the BNH Centre Regulations. The current thinking of the MC is that we should revert to follow the BNZ conditions of play for CoC events and recommend to the Board that this Regulation 6 be changed to incorporate the wording issued by Bowls NZ. This wording is as follows:

<u>Club Championship events leading to Centre Champion of Champion Events and beyond (Singles, Pairs, Triples, Fours, and Mixed Pairs)</u>

If a player and/or player in a team <u>wins</u> a club championship competition that qualifies them for a centre champion of champions event, which goes on to a national champion of champions event, they are ineligible to enter another club's competition in that discipline.

- 1. A player and/or player in a team can only win one club championship or centre champion of champions event per discipline in a single season. For clarity, if a player wins any club championship, in any discipline, then they may NOT enter that same discipline at any other club, in any Centre, in the same season.
- 2. A player and/or player in a team can only play in one active club championship discipline at any one time. For clarity, the player may enter another club's (if they are a full playing member) championship in the same discipline ONLY after the first club's championship in the same discipline has concluded and/or they are knocked out of that club's event.

Interclub Sevens event leading to the National Interclub Sevens Championship

If a player is part of a club's interclub sevens team, that player is not eligible to represent another club in another centre's interclub sevens competition, that advances to the National Interclub Sevens Finals, or be selected to represent another club in the National Interclub Sevens Finals. For clarity, players cannot be selected in two clubs across multiple centres in an interclub sevens pathway event. This rule only applies to an interclub event that progresses to the National Interclub Sevens Finals.

Winter coaching

Going forward could we consider a name change, more inline to what we offer BNH Skills Coaching - module #1; 1 to 5 year bowlers June/July
Two Saturday sessions completed, 37 on 5 July and 45 on 12 July. There has been great positive feedback on the skills provided by the coaching team. The format seems to align to bowlers expectations

The skills that this diverse group of bowlers have shown gives a hint that there is a deficiency of the basics skills being taught - how to hold a bowl, foot location on mat

Our plans of providing coaches courses should assist with improving our club coaches' skills and the number of club coaches for BNH clubs

With the popularity of bowlers wanting coaching would it be timely to consider another course, possibly summer evening sessions

Foundation Course

Thanks to Bowls Auckland and BNZ willingness to adapt their regular one day Foundation course to three evening session courses we have 16 bowlers attending the next three Tuesday's evening sessions at Bowls Orewa

Will discuss another Foundation course then move towards discussions on the Development Course
