Match Committee Report:

MATCH COMMITTEE (MC) REPORT TO THE BOARD – 30 – August 2025

RECENT EVENTS: After a quieter spell for events the Winter cup has been completed and was able despite the occasional weather problems. The results were –

Men - Hobsonville with runners up Birkenhead

Women - Mairangi Bay with runners up Takapuna.

The next events start with the Opening Day Executive fours and we then have a run of them leading into the Metlifecare NZ Masters event at the end of September. It will be a very busy time for the Centre manager and treasurer to cope with these requirements.

TIME LIMIT FOR CENTRE EVENTS: The recent time limits for events was increased from 2% hours pre last season to 2% hours last season. This increasing the time limit exaggerated the time for completing events and was detrimental to the players and officials running the events. Bear in mind that a game with a time limit does not finish at that time. An end started just before the bell runs another 10 minutes or so after, making a 2% game possibly lasting 2% hours. With breaks that means the day with 3 rounds is a minimum of ten hours. If we have to play four rounds in the day it becomes near impossible.

The Match Committee have approved and recommend that the Board amend the time limit for games as —

All qualifying (section) play be 2 hour time limit. (Ends and 21 shots remain the same)

All post section games except the final be 2¼ hour time limit.

All finals be no time limit.

MARKERS FOR SINGLES: Following the memo from the Umpires Committee, the Board should discuss this and come to a conclusion on the way forward. It is a continual yearly problem which we seem to get by on but is never quite as perfect as we would like. The comments from Colin Rogan as attached should also be considered.

The issue regarding markers for singles games was discussed. It was considered too difficult to collect fines from players and not appropriate to fine their club for a player's breach.

It was proposed that the Condition of Play for singles events include the following clause regarding markers:

"If a player who is scheduled to mark a game leaves the venue without prior clearance from the umpire or the event director, they will not be eligible to enter that event in the following year and that this stand down period will be strictly enforced."
