### **Coaching & Development Report:**

Tony Eames completed a Foundation course for 6 BNH bowlers. Could a letter be sent thanking him on his initiative to run the course for Manly and Orewa Bowlers

Tony sent an email to the board explaining/advising that coaches are accredited through BNZ and are therefore policed check to be able to coach youth bowlers Perhaps in the next handbook we can have a byline saying BNH coaches are accredited through BNZ which includes the police check. I think he was pointing out that we call then BNH accredited coaches. I have briefly discussed with Les Eagleton about having Bowls Auckland run the Foundation and development course in winter 2026

I marked one game of the battle of the bridge, well done to the BNH management, the umpires and the event directors. You all showed how professional your/our team is.

## **General Business:**

1. Constitutional matter regarding voting at meetings – Mark Batley highlighted that for Board decisions, the process outlined in the BNH Constitution must be followed. The due process is:
  - a. A proposal which needs to be seconded
  - b. A full discussion must take place with all board members able to offer their opinion
  - c. The Board Chair is to confirm that the proposal has been discussed in full and then to ask for a vote, which should be binding.
2. Grant approval received for website upgrade (\$1,000) – GP to contact ALLTEAMS to ask for a renewed quote to upgrade the BNH website and to determine what can be done for the amount of the grant. It was noted that the version of WORDPRESS is out of date and the site crashes regularly when maintenance and updates are undertaken.
3. There is a vacancy on the board. Current board members were asked to consider who should be approached to fill the vacancy. TP to communicate with the delegates of key clubs that are not currently represented on the board.
4. New Board members are to be added to the website – GP to action
5. MB asked how the Board communicates with our clubs – After discussion, it was suggested that we hold a CLUSTER MEETING on the third week in March 2026. GP to organise.
6. The Pennants survey is being circulated to members of the match committee and those involved in setting up the program of event for the 2025 2026 season. The overall feedback was positive, and it was suggested that the match committee include a similar format in the 2026 2027 events calendar.
