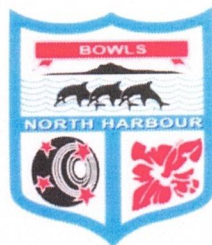

SPECIAL CONDITIONS OF PLAY for BNH MEN's WINTER CUP

1. **General Conditions:** The "General Conditions of Play" as they are available on the Bowls North Harbour website will apply to this event to the extent they are applicable.
2. **Greens:** This event will be played on artificial surface greens.
3. **Clothing:** For this tournament mufti clothing is acceptable.
4. **Umpires:** There will be no umpires appointed to this competition. Ask a person from a neighbouring rink if this is required.
5. **Dead Ends:** If an end becomes dead the jack is placed on the 2 metre mark.
6. **Incorrect Delivery of the Jack:** An incorrectly delivered jack will be placed by the opposing skip.
7. **Time Limit:** A time limit of 1 ¾ hours will apply in all games. If the jack has been delivered before the end of the signalled time, the end will continue and if the end subsequently becomes dead it will be replayed.
8. **Restricting the Movement of Players During Play:** In all games, players will only be allowed to walk up to the head under the following circumstances:
 - Leads: after delivery of their second bowl;
 - Twos: after delivery of their second bowl;
 - Threes: after delivery of their second bowl;
 - Skip: after delivery of their first bowl.
9. **Defaults:** If a team defaults all games then the default will be treated the same as a bye. i.e no points are awarded. If a team defaults in less than the full 5 rounds they will score no points for the rounds defaulted. Their opponents in these rounds will receive three points for a win and the average points for and against of the remaining two games in the section in that round.
10. **Byes in Qualifying Play:** Should there not be an even number of teams then a section(s) may contain a bye. The bye will be treated as a win and no shot differential applied.
11. **Scoring:** After the twos have played their bowls, skips (who may require a measure) will decide on the shot(s) held and a maximum of two shots are to be immediately registered on the scoreboard to the leading team.
12. **Tie in Qualifying:** In the event of a tie in qualifying play, no extra end will be played to determine a winner.
13. **Determining winning teams:** In all Section Play games, three points will be awarded for each game won and one point for a drawn game. Where game points are equal the winning team will be the team with the highest net total of shots. If the game points and the net total of shots are equal the team with the lowest total shots against will be the winner. If these are equal the winning team will be determined by the toss of a coin.
14. **Post section:** The winner and the runner up team of each section will qualify for the post section knockout games on day three. Post section play will be to find a winner of each game played. If the scores are tied at the end of 12 ends, or after the end is completed when the time limit is signalled, then one further end will be played to determine a winner. If that end becomes dead then further ends will be played until a result is found.
15. **Inclement Weather:** In the case of inclement weather eight (8) ends will constitute a game. If weather conditions force an abandonment of play, four completed games will constitute completion of section play, and a result found from the four completed games. Each venue will be considered a separate competition when applying this rule. In the event of the round robin qualifying not being completed, the Event Director, in consultation with the Match Committee, has the discretion to determine the teams for post section play.
16. **Prize Money:** Prize money will be paid to the clubs at the conclusion of the event.
